Extraordinary Business: The OC Parks Staff at Aliso and Wood Canyons Wilderness Park were presented with a framed proclamation from Supervisor Bartlett, 5<sup>th</sup> District, commemorating the official opening of the new AWCWP Visitor Center. Sergio Prince, Community Relations Advisor presented the proclamation on behalf of Supervisor Bartlett.

#### 5. Tour of new Visitor Center

OC Parks Resource staff Rick Shaeffer noted some of the interesting features of the new Visitor Center Complex as the CGA and OC Parks staff toured the area. Specifically mentioned were the garage-door style entrances that can be open to allow for air circulation and immediate access with the shaded outdoor areas; stewardship though reclaimed water being used in the drip irrigation system, collection of rainwater for irrigation; interior dioramas depicting the park's wildlife and habitat; flip panels for younger learners with interactive discoverables; topographical map illustrating trails and their degree of difficulty and a helpful overall view of AWCWP. The open and varied exhibits will encourage visitors to return often. CGA members extended their thanks and appreciation to OC Parks staff for the informative tour.
