Casey Gnadt, Open Space Administrator presented an information PowerPoint presentation on the City of Irvine Open Management Plan. Key points included the history starting in 1988 through a ballot preservation act. 1996 joining the NCCP/hcp Nature Reserve of Orange County, 1998 and 2009 north open space, creation of the Recreation and Reserve Management Plans; 34 miles single and 2 -track trails; have to manage trails as originally designated; Public Works responsible for management and administration of Irvine Ranch Conservancy contract; docent-led tours for the most sensitive habitat, 7 day monitored access for other trails. Northern Open Space 1,700 acres docent-led only, designated high fire area: Southern Open Space 5.000 acres. Irvine's Open Space Team includes Administration, rangers, community service manager for recreation, IRC Contract Staff, Specialized bike team for monitoring. Developed a 5-prong Wildfire Awareness Plan dividing the city into zones. Because of Coastal Fire emergency many missed this excellent presentation. We will review this again at a future Coastal Greenbelt Authority meeting.
