Background


- 2017 Trails Subcommittee recommended the formation of a Trail Ambassador Program to share information about trail safety, etiquette, wayfinding, and natural resources with OC Parks visitors. Staff began developing the Trail Ambassador role, elements, and task descriptions and drafting a Training Manual.
- 2019 OC Parks contractor Irvine Ranch Conservancy (IRC) began refining the Training Manual and building a training program for Ambassadors.
- 2022 The Training Manual was finalized and volunteer training initiated.

A Trail Ambassador:

- Educates visitors about responsible trail use
- Helps ensure a safe and enjoyable visit for all trail users
- Promotes and protects local wildlife and natural habitats

Roles & Responsibilities

Public Interaction

- Engage park visitors in a positive, respectful manner
- Provide information about trail etiquette, safety, park rules, trail/park closures, and maps





Wayfinding

- Use park maps, directional signage, and landmarks to help trail users navigate during their park visit
- Match visitors with the right trail for their skills/desired experience

Wildlife Encounters

 Educate visitors about what wildlife they may see and how to stay safe while on the trails



Trail Closures

 Provide information about closures or re-routes of park trails, whether due to weather, sensitive habitats, wildlife, fire, or other circumstances



Peters Canyon Regional Park History

- Part of original Spanish land grant,
 Rancho Lomas De Santiago
- 1886 Land purchased by James Harvey Irvine I
- 1931 Upper Peters Canyon Reservoir completed
- 1940 Lower Reservoir constructed
- 1992 Irvine Company donated
 340 acres to County








Background

- Park includes 340 acres with 9 miles of trails
- Land must be managed in accordance with the Natural Community Conservation Plan/Habitat Conservation Plan (NCCP/HCP), a state and federal agreement that protects habitat values
- Park's 2019 General Development Plan identifies East Ridge View Trail for realignment due to steepness, heavy erosion, and access difficulty for patrol, maintenance, and emergency vehicles







Goals of Reroute

- Increase public enjoyment of Park
- Enhance sustainability
- Reduce trail maintenance
- Improve trail connectivity
- Improve Park patrol, maintenance, and emergency response capabilities



East Ridge Trail Realignment Peters Canyon Regional Park








Reroute Planning

- In 2022, a working group was formed with OC Parks' facility staff, Natural Resources, Trails Coordinator, and contractor
- Considerations included:
 - Recreation Temporary trail closures, signage and fencing needs, and improved grade and flow
 - Operations Equipment and materials access, timing for season and weather, and special events
 - Sustainability Grade and camber, drainage features, and vehicle accommodation
 - Sensitive resources Native plant and animal species, habitat features, and archaeological/paleontological
- Wildlife Agencies required demonstration of impact avoidance/minimization measures and a habitat restoration plan

Reroute Planning

- Recreation impact avoidance/minimization efforts entailed:
 - Minimizing trail closures, installing signage, and strategic fencing to guide visitors to new route
- Habitat impact avoidance/minimization efforts involved:
 - Flagging and salvaging native plants for decommissioned trail segments
 - Positioning the trail to go through non-native rather than native habitats
 - Performing work outside of nesting season
 - Restoring habitat on decommissioned trail segments









Reroute Implementation

- Work began in Winter 2022 to avoid nesting season, started on November 28 and completed on December 16, 2022
- Work included:
 - Salvaging native plants from the path of the new alignment
 - Installing the new alignment of East Ridge View Trail
 - Connecting the new alignment with Eucalyptus Trail
 - Decommissioning and closing the old alignment
 - Fencing and signing the new and closed segments









Habitat Restoration Implementation

- Goal: Establish self-sustaining, high-quality habitat in the footprint of decommissioned trail segments
- 2022 Site Preparation:
 - Decompact decommissioned trail segments
 - Salvage soil and native plants from new alignment
 - Locally collect native seed
- Installation:
 - 2022 Spread cut vegetation material from new trail over decommissioned trail segments
 - 2022 Plant salvaged material
 - February 2023 Hydroseed with native plant seed
 - 3 Years Maintenance, monitoring, and reporting to Wildlife Agencies
