Barbara Norton, OC Parks Operations Manager, provided background information at the various tour stops and answered the Authority Members' questions.

 - Stop #1 Wood's End Public Access
 - Brief overview of the land ownership, public trail use and connectivity, and land management responsibilities of the Woods End Trails. All new trails will be highlighted during the tour.

Ownership includes Southern California Edison, County of Orange, Cities of Laguna Beach and Laguna Woods, Laguna Beach County Water District. Review of the Laguna Woods acquisition with California Prop 12 funding which provides an entrance to Laguna Coast Wilderness Park from El Toro Road. In 2002, the California Coastal Conservancy gave a \$2,435,000 grant to the City of Laguna Woods to purchase the 10.6-acre Woods End property.

• Stop #2 – Top of Wood's End Trail at Ridgetop Road

• Enjoy expansive view from the ridgetop and see various landmarks in Laguna Coast Wilderness Park.

Noted view of Canyon Trail previously named the Bea Whittlesey Canyon Trail. New trails viewed since the Laguna Coast Wilderness Park GDP include Ridge Top and Woods End trails.

- Stop #3 Top of the Buried Reservoir in the James Dilley Preserve
 - Brief overview of various points of interest visible from this viewpoint.

Noted new trails – Gravel and Edison, Laguna Coast Wilderness Park view and surrounding urban areas, history of Dilley Preserve acquisition by the City of Laguna Beach.

- Stop #4 Barbara's Lake Shoreline
 - Brief history of the Laguna lakes and the watershed and information on how important these are to local wildlife.

History of Barbara's Lake acquisition and of the namesake Barbara Stuart, noticed high level of water from the winter rains and the lake's importance as a water source for wildlife. Observed proximity of the Laguna Woods community.

- Stop #5 Old Laguna Canyon Road Alignment
 - Brief history of the realignment of Laguna Canyon Road and the reconnection of Barbara's Lake to Bubbles' Pond. Brief discussion on restoration of old alignment area.

Timeline for old road alignment restoration and possible future use, comment about the water level height at the northern body of water – a vernal pond.

- Conclusion Nix Nature Center
 - All participants will be transported to the Nix Nature Center for any comments or questions regarding the Field Trip.

Review of the new trails since the Laguna Coast Wilderness Park GDP approval, appreciation to OC Parks staff for the tour and helpful information.
