A. LAGUNA CANYON FOUNDATION (LCF) UPDATE

Jacky Cordero, LCF Deputy Director, shared the following: LCF is in the process of hiring a project manager with an anticipated start date of September 1, 2023. They will focus on the Aliso Creek projects; LCF closed out FY 22–23 books and completed the budget for FY 23–24. LCF board votes on this budget on July 20th; WCB (Wildlife Conservation Board) approved an extension to LCF's current WCB Aliso Creek project. The project was extended 18–24 months with additional funding of \$192,000; LCF Annual Gala is set for Friday, October 6th; LCF recently partnered with Suzi Chauvel and secured \$200,000 annual funding to extend the Title I

South Coast Wilderness Education Program from Grades 2–5 into middle school, high school, and college internship programs. During the 22–23 school year LCF served 2,500 kids on 50 school field trips. The first year coming back from the pandemic; LCF is partnering with Orange County Community Foundation and 7 other local environmental nonprofits (Crystal Cove Conservancy, Banning Ranch, Laguna Ocean Foundation, etc.) on the annual Protect & Preserve Campaign. The Giving Day is set for Wednesday, August 6th; During LCF's FY 22–23, LCF onboarded two new board members (Adele Heuer and Michelle Kremer). Michelle was voted in last month as Board President. LCF is actively working on recruiting a third board member for FY 23–24.

Also noted were the cactus wren survey that is done every 5 years will start soon; NCC recently met with scientists and park staff to help develop consistent trail conditions and evaluation.

V. OC PARKS STAFF UPDATE

A. PARK OPERATIONS — ALL DEPARTMENTS UPDATE

Ev Mena, OC Parks Interim Parks Division Manager, shared the following: OC Parks is hiring 6 new park rangers with the onboarding in process for various facilities; 7 more candidates will start the training process in late July; also interviews for the Resource Specialists will start in late July; Pam Passow has been appointed OC Parks Director; Mike Wilson is the Interim OC Parks Director of Operations. Also, a Park Ranger 2 will soon be transferred to LCWP.

B. LAGUNA COAST WILDERNESS PARK (LCWP) AND ALISO AND WOOD CANYONS WILDERNESS PARK (AWCWP) SPOTLIGHT

1. LCWP Update

Brad Barker, OC Parks Supervising Park Ranger II, shared the following: many thanks to Barbara Norton, OC Parks for organizing the much-appreciated Woods End tour 2022-2023 Rainfall to date 25.6 inches necessitating many repairs to trails and multi-purpose roads; 50 Pacific Pocket mice will be released in May, this is a San Diego Museum project; recent hiring of a new maintenance 1 staff for LCWP; Nix Nature Center still has reduced hours due to lack of staffing, Laguna Canyon Foundation and OC Parks Reserves are helping to make up for lack of staff.

2. AWCWP Update

Adam Martinez, OC Parks Supervising Park Ranger I, shared the following: the Aliso Creek East project is completed; Soka University installed a fiberoptic cable in the creek but without any damage to the creek; AWCWP is short a maintenance staff member and office technician. The multipurpose road grading has not been done yet by OCFA but will start soon along with OC Parks heavy equipment; Laguna Canyon Foundation has help tremendously with trail clearing/repairs.

Mark Trestik, City of Laguna Beach City Engineer, noted no update at this time, but within the next 12 months there will be public workshops regarding the design.

C. LAGUNA CANYON ROAD WIDENING AND SAFETY PROJECT UPDATE

OC Parks or Caltrans Staff will share an update on Caltrans' Laguna Canyon Road Widening and Safety Project.

This Agenda Item was heard before Agenda Item IV.

Carmen Lo, CALTRANS Associate Environmental Planner District 12, coordinated the presentation. CALTRANS Staff and Consultants comprised the team for the presentation and shared the following: Construction started in December 2022; Components of the project include: Component 1 – Channel restoration, Concrete Check Dam; Component 2 – Standard length for merge lane, Reconfigure left-turn lane from El Toro; Component 3 – Shoulder widening for Class II Bike Lanes and Undergrounding of Utilities; The combined 133 and El Toro Road projects are under CALTRANS and County of Orange. Tentatively scheduled for

completion by September 2025; Work activities are restricted during peak morning and afternoon traffic times, much of the work is done during the night behind the K-Rails; Project benefits include: drainage improvements, safety improvements, visual improvements, and bike lanes; Each component of the project was explained by the Team; Immediate questions by the Coastal Greenbelt Authority members were: Has the historic well site on the Anneliese property been protected? CALTRANS indicated that the well cap was still there. Will the Retaining basin/check dam next to the 73 off-ramp remain on that side of Laguna Canyon Road? CALTRANS said yes;

The public had a number of questions or clarifications – Toni Iseman, Penny Milne, Johanna Felder, Laura Cohen, Gayle Waite: many expressed concern about the corner parcel with the new driveway for entering and exiting Anneliese school property. Specifically, who will manage the property, maintain the habitat and wildlife protection, will the 6- foot fence lining the new driveway remain? Another key concern of the public and CGA members was the merge lane that starts going south at the Laguna Canyon Road/El Toro Road intersection. Will the merge lane end at a safe distance from the Willow Canyon Park gate to allow entering and exiting vehicles to safely get to the middle lane needed without crossing the merge lane?

The public and Coastal Greenbelt Authority members appreciated the CALTRANS presentation and explanations. CALTRANS noted they would further respond to questions in a few weeks.

Member Clark shared recent recognition of the Irvine Laguna Wildlife Corridor by the Los Angeles Regional 30x30 planning group (Power in Nature) for Los Angeles, Orange, San Bernardino, and Ventura counties. Our corridor was identified as the #1 project to address the problem of climate resiliency.

Barbara Norton, OC Parks Operations Manager, thanked the OC Parks staff for their assistance with the Woods End tour and all that they do for LCWP and AWCWP. She noted there are a number of trails and areas not included in the LCWP General Development and Resources Management Plans. These include: Old Emeralds Falls – new location; Woods End; Ridgetop Trail; Blackjack Trail; Morro Sliver – acreage not included – extended Bommer Ridge connection from Dartmoor to Emerald Canyon; Lizard Trail in 2016; Mary's Trail; and area east of Laguna Canyon Road off Fire Road.

Authority Members discussed opportunities for another tour – Barbara Norton will determine the best time. Chair Fegraus asked about the timing for the next OC Parks budget. Any suggestions for document amendments would most likely be in the 2025 OC Parks Budget. Authority Members talked about reviewing the GDP and RMP documents. Authority Members will review sections of the documents using the OC Parks website link and share their questions about possible document updates beyond the new trails and areas with the Authority Members at the next Authority meeting.
