2. PUBLIC PARTICIPATION

Members of the public are welcome to address the Authority on items of public interest that are within the jurisdiction of the Authority and are not listed as an agenda item. Welcomed Phillip Bettencourt, former president of Cortese Properties and helpful with purchases of additional land for Laguna Coast Wilderness Park, including Woods End, owned by City of Laguna Woods and leased to the County of Orange for parkland.

3. MINUTES

Meeting Minutes, November 13, 2019. Corrections/Additions Recommended Action: Approve meeting minutes or modifications as appropriate. On a motion by Maloney with a second by Conners, the minutes were approved unanimously.

- **4. CGA MEMBERS AND PARTNERS ANNOUNCEMENTS AND UPDATES –** *Unanimously Received and Filed on a motion by Clark with a second by Maloney*
 - A. Update by Laguna Canyon Foundation by a LCF representative. Paula Olson shared the following: LCF received a 4-year grant awarded through our CDFW Local Assistance Grant Program with the \$709,000 funding by the CA Wildlife Conservation Board. The AWCWP 21-acre restoration project is between Pacific Park and Avila Rd. The riparian transitional and coastal sage scrub restoration will improve conditions for the southwestern pond turtle and Least Bell's Vireo. It involves site preparation, plant installation, hydroseeding and site maintenance in support of plant establishment. During 2019: 123 Long term volunteers served 7,288 hours, 487 short term volunteers served 1,593 hours, and 610 volunteers for 8,881 hours. These volunteers made possible the restoration activities 17,000 plants and 1,200 pounds of seeds. Also, the Education activities: 12 Partner Schools grades second through fifth, 3,267 students, 101 teachers, 232 parents/chaperones participated in 66 field trips. LCF now has a Team of 7 educators. LCF is officially in their headquarters!
 - B. Update by Natural Communities Coalition by a NCC representative. *Jim Sulentich, Executive Director and Danny Fry, Wildland Fire Management Coordinator shared:*Laguna Greenbelt's December Wildlife Corridor presentation to the NCC board, current restoration of 4 areas for Western spade-foot toad habitat which will include intermittent ponds and 40 cactus clumps.
 - C. Update by City of Laguna Beach regarding open space in Laguna Beach. Christa Johnson, Assistant City Manager shared: In 2019 as part of the wildfire safety program city utilized 1,200 goats in 3 herds for fuel modification, other funded programs for fuel modification in Laguna Canyon and Top of the World area, council approved funding for full-time LB Fire Department Fire Prevention position; a major parcel in Rimrock Canyon has been donated to UCLA and Pepperdine question of

- what will happen to the non-buildable parcels without street access. Another large section of Rimrock Canyon was preserved as open space with state bond funding.

- G. Update regarding Open Space from Laguna Niguel. Ron Rivera, Recreation Manager stated there was no new information at this time.
- **5. OC PARKS STAFF UPDATE –** *Unanimously Received and Filed on a motion by Johnson and second by Clark*
 - A. Park Operations All Departments Update: John Gannaway, OC Parks shared: New Park Ranger 1 Academy class with 12 participants underway now 10 weeks in class, 14 weeks out in the parks. Rigorous 1 year training in many disciplines. Currently OC Parks has 52 rangers, many retirements creating vacancies, new recruitment program underway.
 - B. Spotlight on Laguna Coast Wilderness and Aliso and Wood Canyons Wilderness Parks: Park staff will highlight recent accomplishments, activities and upcoming events.

Laguna Coast Wilderness Park Update: Ranger Stegner shared the Ridge Trail re-route; restoration of Pacific Pocket Mice habitat to prevent predators from burrowing under the barrier fencing and that more mice will be re-introduced; trails in good shape due to careful preparation before the rainy season – trying to slope the trails to allow the water to drain off and to prevent standing water on the trails.

Aliso and Wood Canyons Wilderness Park Update: Ranger Barker shared more than 8 inches of rain in December which caused 20 days of park closure, but trails held up well; delay with Visitor Center opening due to fire sprinkler issue

Johnson shared that the City of Laguna Beach has a new trial Dog Park at Moulton Meadows. Clark noted that the Laguna Greenbelt Inc. annual meeting is February 27th at 7 p.m. Elisabeth Brown, retiring president will be honored. Dr. Brown served on the CGA from 1991 to 2011 as a representative of Laguna Beach Environmental organizations and the Laguna Canyon Homeowners.
