3. MINUTES

Meeting Minutes, November 10, 2020. Corrections/Additions Recommended Action: On a motion by Conners with a second by Felder, the minutes of November 10, 2020 were unanimously approved with one correction (Prince was not present).

4. CGA MEMBERS AND PARTNERS ANNOUNCEMENTS AND UPDATES

- A. Laguna Canyon Foundation Update by a LCF representative. *Hallie Jones, ED* shared the following: Challenging time for staff and volunteers but December volunteer hours were still 40% from previous December field staff and volunteers worked on restoration projects following all health protocols. Question from the public on the Arundo in Aliso Creek and permits for that section of the creek need a response from OC Public Works.
- B. Natural Communities Coalition Update by a NCC representative. Darin Loughrey shared the goals of the NCCP/HCP as working to balance nature and recreation, welcome to new staff member, Mendel Stewart, Natural Resources Coordinator. NCC publishes a quarterly newsletter to receive the newsletter contact Darin at <u>dloughrey@occonservation.org</u>

- **C**. Update by City of Laguna Beach regarding open space in Laguna Beach. Councilmember Iseman noted the city is in lockdown, very difficult for tourist industry, mask compliance is working for residents, but more difficult with compliance by tourists. Question by Prince has the graffiti been taken care of at the Alta Laguna knoll site – yes OC Parks, LB County Water District removed all graffiti. Clark asked about land use designation for certain parcels in Laguna Canyon – need to check the files.
- **D**. Update regarding the City of Irvine's Open Space Preserve. Smith shared the December 28, 2020 trail closures due to rain; invasive pest inspections starting soon; wildlife corridor maintenance/planting from Irvine Boulevard to Aster; increased usage of trails; updating signage.
- E. Update on the City of Newport Beach's Open Space. Breaux shared Buck Gully closure for IRC to do trail maintenance and restoration on illegal trails from the urban areas; two bobcats sighted; Big Canyon with Public Works restoration of area clearing for planting 10,000 native plants, redirect creek to flow naturally into Newport Bay; had to pull staff from the field due to COVID.
- F. Update regarding Open Space from Aliso Viejo. Not Available.
- G. Update regarding Open Space from Laguna Niguel. Not Available.

5. OC PARKS STAFF UPDATE

- A. Park Operations All Departments Update Norton noted there is an uptick on the homeless encampments in the inland areas, working with OC Sheriff Homeless Authority. Among other issues there is always a concern about fire. Prince stated that the Fifth District Supervisor promotes the OC Fire Watch, OC Parks appreciates this support.
- B. Spotlight on Laguna Coast Wilderness and Aliso and Wood Canyons Wilderness Parks: Park staff will highlight recent accomplishments, activities and upcoming events.

Laguna Coast Wilderness Park Update: Supervising Park Ranger Matt Stegner shared the following: Pacific Pocket Mouse project – working with project partners to increase the size of the mice enclosure to help their viability; removed 2 miles of unauthorized trails in December with the CA Conservation Corps; large attendance numbers – this high volume of use does degrade the trails necessitating more maintenance, parking lots full almost every day; question of how to be sure there isn't any illegal substance growth in Los Trancos Canyon – surveys by drones ascertained there isn't any; Laura Cohen – Resource Specialists has a virtual tour available for the Martin Luther King holiday.

Aliso and Wood Canyons Wilderness Park Update: Ranger Sean Bengstrom shared the following: outstanding attendance – November 32,400 visitors and December 34,900 visitors; active wildlife with sightings of white-tailed kite, bobcats and 14 mule deer over one weekend; Visitor Center update – interpretive exhibits should be completed by late February; limited rain so far has helped to keep trails in good shape; but working on 5 Oaks Trail, and Aliso Creek East will be closed due to SOCWA sludge pipeline construction. Questions by CGA members: with attendance so high is there damage to trails? – probably, also crowded trails, more first-time users and remote rescues. Is there a set capacity to stipulate closing the park? – No. Any smoking violations? – No. Hikers and Cyclist numbers – more in one category? – No, more in both categories.

6. RECEIVE AND FILE MATTERS

- A. Report by Clark/Fegraus on Irvine Wildlife Corridor Update on activities. Recommended Action: Receive and File Clark shared the progress despite the pandemic restrictions made by the Laguna Greenbelt Wildlife Corridor Working Team: established the Science Advisors and a schedule to meet every two months to discuss specific subjects; February's meeting of the Science Advisors will focus on the human misuse and intrusions into the wildlife corridor; working on a document to help guidelines for planning/design/construction near open space areas; developing a virtual tour of the wildlife corridor using drone footage, videos, graphics and maps for various audiences – technical, public agencies, education; recent press coverage of video of fire at Irvine Boulevard and images of coyotes returning to the burned area. Questions: Do we have a wildlife survey which focuses on the health of the wildlife? Loughrey, NCC answered that they are working with Utah State University on a study of the health of the reserve, Mendel Stewart, NCC's Natural Resources Coordinator is helping to develop the study metrics. Continue item to March meeting.
- **B.** Update Caltrans Laguna Canyon Road Project. Recommended Action: Receive and File *Norton, OC Park stated there is no new information. Continue item to March meeting.*

C. Fire Safety at LCWP and AWCWP during Coastal Red Flag Days Update Recommended Action: Receive and File Norton noted that the Protocol, as shared at the last CGA meeting, leaves decision making to each site manager based on conditions at each site.

Motion to Receive and File Agenda Items 6. A, B, C On a motion by Felder with a second by Iseman it was unanimously approved to Receive and File Agenda Items 6. A, B, and C.

7. ACTION ITEMS

A. Report by staff on Trails Sub-Committee review of a Proposed Pilot Project for Trail Use Designations.

Recommended Action: Make recommendation to OC Parks Commission to support pilot project. OC Parks Staff Pam Passow presented the proposed Pilot Project Trail Use Designations with a focus on the suggested changes for LCWP and AWCWP. Proposed changes for AWCWP include Lynx Trail change from multi-use to Bikes only downhill, no other users downhill; Cholla Trail change from multi-use to Bikes uphill only, but other users remain the same (bidirectional). For LCWP – Laguna Ridge Trail change from hiking/biking to bikes only downhill. Old Emerald Trail – change from hiking/biking to bikes remains bidirectional.

Questions and Concerns: Who determined which trails for change of use? OC Parks staff and visitors; Project schedule? First report after 3 months, at 6 months a decision to conclude or extend project; Who makes the final project approval? OC Parks Commission. Concern with enforcement: who will enforce the new designations? OC Parks Staff with hopefully assistance from Laguna Canyon Foundation staff and volunteers; Enforcement starts with education, users helping each other, signage encouraging reporting of illegal use. How often are hikes injured by bikers? Not often, more an issue of crowding on the trails. Also noted that each trail and its condition will be assessed before starting the project. Main concerns: enforcement, education and reporting and additional OC Parks staff responsibilities.

CGA members asked that this item remain on future agendas for status reports. Concern if the pilot program becomes permanent that actions be taken to make sure the park's governing documents reflect these changes through a public review process (General Development and Resource Management Plans).

On a motion by Conners with a second by Iseman it was unanimously approved to send a letter to the OC Parks Commission with our support of the pilot program, but also that all future actions on this item are reviewed by the CGA before final actions, and that education, signage program are provided as Outreach and sensitive resources are protected. **B**. Election of Officers for 2021 – Chair and Vice Chair Recommended Action: Nominations and Motion to elect 2021 Officers. On a motion by Clark with a second by Conners, Mary Fegraus was nominated as Chair, and Cynthia Conners as Vice Chair. The motion passed unanimously.

8. CGA MEMBERS COMMENTS AND REPORT

At this time CGA members may comment on non-agenda matters and ask questions of staff, provided that no action may be taken on off-agenda items unless authorized by law. *Felder noted that the February 1 meeting of the Laguna Canyon Conservancy will feature Hallie Jones, Laguna Canyon Foundation, as the speaker. Question of when the Open Space Ordinance in Laguna Beach expires? 2028? Question by Prince – any new e-bike decisions for OC Parks? Not at this time.*
